PROVISION OF REQUESTED INFORMATION

Thank you for your request for information about policy and procedures surrounding Avian Influenza outbreaks which we received on 26th January 2021. Your request has been handled under the Freedom of Information Act 2000 (FOI).

The information you requested and our response is detailed below:

"I am making a FOI request for all information related to the contagious nature of bird flu, the efficacy of isolation procedures, and what process was used in determination of DEFRA's gassing of poultry around the Kent area outbreak of bird flu."

Please find below a link to the Policy paper - Notifiable avian disease control strategy that can be found on GOV.UK. This document contains the policy around Avian Influenza.

With regard to the culling process specifically, please see some further information below:

APHA assign an APHA Case Officer and Welfare Vet to oversee culling operations on an Infected Premises (IP). The Welfare Vet makes decisions on the most appropriate method of culling, taking into consideration a number of different variables. In accordance with the Great Britain Notifiable Avian Disease Control Strategy, APHA's priority was to complete the culling operation in an efficient and timely manner so as to

minimise the risk of spread of disease whilst safeguarding the welfare of the birds at the time of killing.

In the case of the outbreak in the Kent area, Containerised Gassing Units (CGUs) were deployed as the preferred method of choice to achieve the objectives and the key principles described in the NAD control strategy. The gassing method used is a proven method for the rapid and humane depopulation of poultry premises and complies with the provisions set out in the Welfare of Animals at the Time of Killing (England) regulations 2015 (WATOK) and Annex 1 of EC regulations on the protection of animals at the time of killing (EC 1099/2009). Alternate methods are also considered as part of this process and may be further deployed should any issues be identified with the primary culling method due to practical and welfare reasons to do with the anatomy of the birds.

Information disclosed in response to this FOI request is releasable to the public. In keeping with the spirit and effect of the FOI and the government's Transparency Agenda, this letter and the information disclosed to you may be placed on GOV.UK, together with any related information that will provide a key to its wider context. No information identifying you will be placed on the GOV.UK website.
